In 2023, Family Health Center of Worcester (FHCW) made significant strides in enhancing community healthcare through infrastructure improvements, strengthening our board of directors, and staff-led initiatives like the *Better Together* program. Like many health care organizations, the agency faced challenges related to healthcare access and resource demand, but FHCW remained committed to providing responsive care to all members of the Worcester community.





Better Together

The *Better Together* initiative at Family Health Center of Worcester was designed to enhance operational efficiencies, financial procedures, and patient experience through a collaborative 'all hands on deck' approach.

The Better Together plan resulted in:

- Pay increases for all staff
- Onboard best-in-class finance team
- Reduced call-center wait by 40%
- Achieving 30+ days cash on hand
- Much more!

Fostering the Future

Throughout 2023, Family Health Center of Worcester reinforced the organization's stability to build a foundation for the future: Growing the patient-led board of directors, deepening community relationships, and securing a many grants, including a \$2.9M grant from the Massachusetts Executive Office of Health and Human Services for infrastructure and patient services improvements.


Patients Currently Living in Worcester




